(the "Manager") of 484,848 CERET units on 29 January 2021 and 730,525 CERET units on 2 February 2021 following the Form 6 notification by the Manager on 1 April 2021. The disposal of the CERET units by the Manager reduced the deemed interest of Cromwell Property Group in CERET units to 27.99% following the issue of 8,011,760 CERET units pursuant to the CERET distribution reinvestment plan.
