We would like to update the ownership percentage of Mr Andrew L. Tan, as a substantial shareholder of both Hillsboro Capital, Ltd. and Worldwide Property Financing Limited. Hillsboro Capital, Ltd. and Worldwide Property Financing Limited are unitholders of Cromwell European REIT, directly owning 39,456,460 units, and 1,754,000 units in Cromwell European REIT, respectively.

Mr Andrew L. Tan is a substantial shareholder of the holding entities Hillsboro Capital, Ltd. (owning actual 36.4% economic beneficial interest) and Worldwide Property Financing Limited (owning actual 40% economic beneficial interest). Under Section 4(5) of the SFA, Mr Andrew L. Tan's deemed interest is 100%. Hillsboro Capital, Ltd. directly owns 39,456,460 units, representing 7.0158% unitholding in Cromwell European REIT, and Worldwide Property Financing Limited directly owns 1,754,000 units, representing 0.3119% unitholding in Cromwell European REIT. Accordingly, Mr Andrew L. Tan's effective beneficial interest in units of Cromwell European REIT is 2.679%.
